I give devise and bequeath unto

Powell a certain part of my
real estate, bounded and described
as follows namely, beginning at the
west end of the said Henry Callow
Powells rear line on the sea
shore, thence westerly in what line
the rear corner of the said
shore may be to a certain bridge
on the south side of what is known
by the name of Rocky Point
thence South east by east to
John Lanes wall line thence
North east following the course of
said line to the said Henry Callow
Powells rear line thence to the

place of bequeathing to have and
to hold the same to the said
Henry Walton Powell his heirs
and assigns forever

I give devise and bequeath
unto my beloved son John Robert
Powell all the part of my real
estate which heretofore depended
of together with all my personal
property of whatever kind owned
by me at the time of my decease
to have and to hold the same
to the said John Robert Powell
and his heirs and assigns forever
I order and it is my will that my
executor John Robert Powell
be allowed to follow with my
son the said John Robert
Powell after my decease and
be supported by him until he is
worthy one year of age
I nominate and appoint my son
the said John Robert Powell to be
executor of this my last will
and testament
to the testimony whereof I have
hereunto set my hand and seal
at Bont-Kabon in the County
of Pacer quene this nineteenth
day of September in the year

hundred and eighty one
